

FAMILY PROMOTION The My Energy Kit Challenge Family Rewards Official Rules

No entry fee or purchase necessary to enter or win the My Energy Kit Challenge Family Rewards programs ("Family Promotion").

The 2022-23 Family Promotion entry period begins July 1, 2022 and ends on May 31, 2023. Winners will be announced no later than June 15, 2023. Prizes will be awarded twice during the promotion period and no later than August 15, 2023. This Family Promotion is subject to all applicable laws and regulations. Void where prohibited by law. The sponsor of this Family Promotion is The National Theatre for Children, Inc. ("Sponsor" or "NTC").

By entering and participating in the Family Promotion, participant ("Entrant"): (1) fully and unconditionally agrees to accept and be bound by these "Official Rules" and by all decisions of Sponsor, which include, without limitation, decisions regarding eligibility, winners and the interpretation of the terms used in these Official Rules, which shall be final and binding in all respects; and (2) represents and warrants that all information provided by Entrant in connection with the Family Promotion is true, accurate and complete as of the date of entry.

- 1. OBJECTIVE: NTC seeks to reward families who sign up for the Duke Energy kit and are counted towards the School Promotion. As part of an energy literacy curriculum, NTC is delivering educational performances and sending students home with Energy Efficiency Kit request forms. By requesting the free Energy Efficiency Kit, the family will be automatically entered into the Family Promotion, with a chance to win one of ten (10) family cash prizes valued at \$250 each. Family Promotion drawings will be held ten times during the promotion period. Each winner will be drawn within the first week of the following month (the August winner will be drawn within the first week of September 2022; the September winner will be drawn the first week of October 2022; and so on through the May winner in June 2023).
- 2. **ELIGIBILITY:** This Promotion is open to any Duke customer family in the Duke Energy and Duke Energy Progress service area states of Indiana, North Carolina and South Carolina (including private or public institutions) who has a child participating in The National Theatre for Children's Duke Energy and Duke Energy Progress Energy Program. To be eligible for the Family Promotion, families must request an eligible Duke Energy or Duke Energy Progress Energy Efficiency Kit. A minimum of 50 total household requests per month is required for the monthly drawing to take place. Should the minimum not be met, the option to draw two (2) winners in a subsequent month may be utilized.

All entrants must meet the following criteria:

- a. Must be at least 18 years of age at the time of drawing.
- **b.** Must have children participating in The National Theatre for Children's Duke Energy and Duke Energy Progress Program.
- **c.** Must properly submit registration provided by Duke Energy and Duke Energy Progress for Energy Efficiency Kit requests.
- **d.** Valid registration for requests must be on file with NTC two days before the final drawings or by June 9, 2023.

- **3. HOW TO ENTER**: To enter the Family Promotion, families must simply request an eligible Energy Efficiency Kit and completely fill out the corresponding request forms and paperwork. Families who request an eligible kit will automatically be entered into the Family Promotion.
- 4. ENTRY GUIDELINES AND RESTRICTIONS: No entry fee or purchase necessary. Possession of an entry does not constitute valid proof of delivery or receipt. Any attempt to enter the Family Promotion in a manner other than as permitted in Section 3 shall be VOID and subject Entrant to disqualification from further participation in the Family Promotion. Entries received from persons not meeting eligibility requirements will be disqualified. Sponsor shall not be liable for late, incomplete or inaccurate entry forms or sign-up submissions, or for technical, hardware or software failures of any kind, lost or unavailable network connection, or failed, incomplete, garbled or delayed computer transmissions, telephone connections or any human error which may occur in the receipt of the entries in the Family Promotion.
- 5. SUBMISSION DEADLINE: The submission deadline will be strictly enforced. Entries into each drawing must be submitted during the specified month, as outlined in **Section 1**. Automatic entry in the Family Promotion will not be accepted based on requests beyond May 31, 2023 for the 2022-23 Family Promotion period, and any requests received after any given drawing will not be accepted into that given drawing.
- 6. WINNER(S): The winning families will be notified by email or by a mailed letter sent to the address associated with their request no later than three (3) days after they are drawn as a winner. Upon confirmation of eligibility, prizes will be awarded within thirty (30) days. Sponsor shall pay for all shipping and handling costs associated with the distribution of prizes. Prizes are guaranteed to be awarded in accordance with these rules.

The winning family may be required to sign an Affidavit of Eligibility/Release of Liability/Prize Acceptance Form upon being notified as a winner. Noncompliance may result in disqualification and an alternate winner(s) may be selected.

7. PRIZES: Eligible families entered in the Family Promotion will be eligible to win one of ten (10) family promotion cash prizes valued at \$250 each. Family Promotion drawings will be held during the time frame listed in Section 1. Unique complete requests submitted between August 1, 2022 and December 31, 2022 will be included in each of the five fall drawings. Unique complete requests submitted between January 1, 2023 and May 31, 2023 will be included in the five winter/spring drawings. The retail value of each prize, including shipping and handling, is \$250. The odds of winning are dependent on the number of valid submissions. The total prize amount awarded in the Family Promotion is approximately \$2,500. All prizes will be awarded in connection with the Family Promotion, and in no event will more than the stated number of prizes be awarded.

Within thirty (30) days of the announcement of the winner(s), Sponsor will provide winner(s) with required documents to be completed and returned to Sponsor. A prize will be awarded within ten (10) days of receipt of documents, or a voucher, certificate or other document giving winner(s) unconditional right to receive the prize. All prizes are non-transferable and non-endorsable and non-cash prizes cannot be redeemed for cash. All costs, fees, expenses and taxes (including without limitation federal, state and local taxes) associated with any element of any prize not explicitly stated herein as being provided (and the reporting consequences thereof) are the sole and exclusive responsibility of the winner(s). All income taxes associated with the acceptance of a prize are the sole responsibility of the winner(s). For South Carolina residents, Award Rules are as stated within these Promotion Rules.

8. DISQUALIFICATION/INELIGIBILITY: Without limiting any other provision of these Official Rules, the Sponsor reserves the right, at any time and in their sole discretion, to disqualify and/or deem a participant ineligible to participate in the Family Promotion. Furthermore, the Sponsor reserves the right, in their sole and absolute discretion, to disregard and/or deem VOID such Entrant's entry in the Family Promotion.

- 9. WINNER(S) LIST: To request a list of winners, send a self-addressed stamped envelope to The National Theatre for Children, Inc., ATTN: My Energy Kit Challenge Family Promotion Winner(s) List, 7003 West Lake Street, Suite 200, Minneapolis, MN 55426. Requests must be received by August 4, 2023 for the 2022-23 Family Promotion.
- **10. AGREEMENT TO OFFICIAL RULES:** By participating, Entrant agrees and accepts the Official Rules and the decisions of the winning families with respect to the Family Promotion, and by entering the Family Promotion, Entrant agrees to waive any right to claim ambiguity or error in the Official Rules.
- 11. RELEASE OF LIABILITY: By participating, Entrant agrees to release Sponsor, its agents, representatives, affiliates and employees from and against any and all liability for any injuries, losses and/or damages caused by or resulting from entry or participating in the Family Promotion, or resulting from the acceptance, possession or use of the prize(s). Sponsor is not responsible for any expenses incurred by Entrant in connection with participation in the Family Promotion.
- 12. MODIFICATION/TERMINATION OF OFFICIAL RULES: Sponsor further reserves the right to modify any terms of the Family Promotion at any time at Sponsor's sole discretion. Sponsor further reserves the right to terminate the Family Promotion at any time at Sponsor's sole discretion. Sponsor shall assume no responsibility for cancellation due to labor strike industry conditions, commercial viability or any other cause beyond Sponsor's reasonable control.
- **13. PUBLICITY:** By participating, Entrant:
 - **a.** Grants Sponsor permission to use Entrant's submission in the promotion of the Family Promotion and any future promotion(s);
 - **b.** Agrees to cooperate with Sponsor's media partners in any promotional materials and/or advertising of the Family Promotion, including use of Entrant's name and school information in any promotional materials and/or advertising of the Family Promotion, except where prohibited by law; and
 - c. Agrees to participate in any follow up surveys conducted by Sponsor or any of its affiliates.
- **14. LAW:** The Family Promotion shall be conducted in accordance with the laws of the State of Minnesota. All disputes concerning these terms and the Family Promotion shall be adjudicated in the federal or state courts having jurisdiction over Hennepin County, Minneapolis, Minnesota USA.
